Projects that the organization are involved in include, but are not limited to, urban deer transplanted, water installation (i.e. guzzlers), juniper removal, reseeding, and rehabilitation of forage for deer species. At the close of 2016, the Mule Deer Foundation has rehabilitated and preserved over 1.5 million acres of critical Mule Deer and Black-Tailed Deer Habitat.
