Members receive educational materials and are invited to support our local and national projects by attending Chapter and National events held throughout the year. The Western Hunting and Conservation Expo is an annual convention that includes vendors and outfitters displaying and selling their products. In conjunction with this there are educational seminars and meetings held regarding conservation. These meetings are held with members, volunteers and state and federal partners.

The Mule Deer Foundation works closely with its members and partners to facilitate the rehabilitation of Mule Deer, Black-Tailed Deer, and their habitat.
