

Mule Deer Foundation Ultimate Giveaway Terms and Conditions

1. PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. STATE AND LOCAL DRAWING LAWS WILL APPLY. VOID WHERE PROHIBITED BY LAW. NEED NOT BE PRESENT TO WIN.

2. Sponsors: Coastal Alaska Adventures Yacht Based Hunts, R&K Hunting Company, Reggear Outfitters, Snowy MTN Rifles, QUIETKAT, Vortex Optics, Badlands, Big O Tires South Orem Utah, and SuperATV.

3. Entries will be accepted during the time and dates noted in the Promotional Message (the "Giveaway Period"). All references to a time of day are references to the time in Salt Lake City, UT. MDF is not responsible for lost, misplaced, illegible, mutilated, incomplete or undelivered entries, and such entries will be deemed invalid. There are no limits on the number of entries an individual can purchase.

5. Drawing: A representative of the Sponsors or an MDF representative will randomly select one (1) potential winner from all eligible entries received during the Giveaway Period. A total of 40,000 entries have been printed for "The Giveaway". The potential winner will be notified by phone and/or by email, whichever is deemed appropriate by MDF, using the contact information provided on the entry. If potential winner does not respond to notification within seven (7) days, MDF does reserve the right to disqualify the potential winner and randomly draw an alternate winner. Each of the potential winners (and alternate winners if applicable) must sign and return to MDF a completed W-9.
